# PERSONAL ENGLISH PORTFOLIO IBIS

#### 1. BACKGROUND INFORMATION

Before I give all the information required for this personal English portfolio I would like to tell something about my level of English before I started with International Business & Innovation Studies and in particular with the lesson English term 1. In my opinion this is necessarily for giving a good reflection about the things that I have learned from the English lessons this first term.

Like every Dutch student my lessons of English started very basically at primary school, continued at secondary school and contained mostly learning words from a book and making boring exercises. That those exercises were boring doesn't interest me that much and isn't important for this portfolio however it is meaningful to notice that such an classic way of learning didn't bring me a lot and in my opinion you can't learn a language by sitting two or three hours every week in class and making exercises.

Because I wanted to be good at English I chose to go abroad and hopefully to improve it that way. It did and a couple of weeks staying in Ghana and travelling through Europe definitely improved my English and the only reason why it was, was because I constantly was surrounded with it and had no other choice than speaking English.

Of course this is mostly about speaking and listening and doesn't contain writing but the one thing I know is that the classic way of teaching didn't help me that much to improve my general English and thus also writing skills.
